Update on the Provisionals from the past election. There were 3 total – 2 Out of Precinct and 1 IDR ballot.

**SUPERVISOR'S REPORT - Month of December 2022**

- The Daily Work log of voter registration applications processed for the month of November 2022 totaled 1,698
- The transferred voters that moved into Newton County totaled 404.
- The transferred voters that moved out of Newton County totaled 395.
- The registered voters that requested to be removed from the Georgia electors list totaled zero.
- The deceased voters removed systematically by Secretary of State office totaled 56
- The deceased voters list provided by the Secretary of State office for verification by the Board of Elections total 78.
- The felon voters list verified by the Secretary of State office was systematically removed from the Felon 40-day clock notification processed total of 26.
- Newton County voter notification from the county clerk's office for removal request for mental capacity zero.
- Newton County voter moved out of state totaled 2.
- The registered voters totaled 88,380 of December 1, 2022.
- The registered voters listed as active totaled 77,700
- The registered voters listed as inactive totaled 10,680

The Budget Comparison Statement as of December 2022 has been provided.

The Board thanked the election team for the great job during the December 06, 2022 - (General Election / Run-Off election) inclusive of advance voting poll workers, election day poll workers and office staffed full time and contracted.

There was an article referenced in the AJC to compliment the great customer service that was provided during advance voting by Newton County by a voter who was a first time voter.

The Board thanked Dustin Thompson for the services that he provided to the Elections Office. Dustin will complete his assignment as a board member on 12-31-2022.
