

**A RESOLUTION
BY THE BOARD OF COMMISSIONERS OF NEWTON COUNTY, GEORGIA,
DECLARING COUNTY LINE ROAD EAST ABANDONED
AND FOR OTHER PURPOSES.**

WHEREAS, pursuant to the Official Code of Georgia Annotated (“O.C.G.A.”) § 32-7-1, the County is authorized to abandon any public road under its jurisdiction when such abandonment is deemed to be in the public interest;

WHEREAS, the portion of County Line Road East located to the north of Shire Parkway was deemed to serve no public interest and was abandoned by Newton County Resolution dated June 17, 2007; and that portion of County Line Road East located to the south of Shire Parkway was not abandoned at that time;

WHEREAS, attached hereto marked Exhibit A is a sketch or plat of County Line Road East south of Shire Parkway and all corresponding right-of-way lying in Land Lots 104, 105, 127, and 128 of the 1st District of Newton County, Georgia (“County Line Road East”);

WHEREAS, O.C.G.A. § 32-7-2 provides the statutory procedure that the County must follow to abandon a public road;

WHEREAS, at the Board’s December 5, 2017, regular meeting, the Board determined that the removal of County Line Road East from the County’s road system was in the best public interest;

WHEREAS, a public hearing was held on January 2, 2018, regarding the abandonment of County Line Road East;

WHEREAS, pursuant to O.C.G.A. § 32-7-2(b)(1), notice of the Board’s determination was duly published in the County’s legal organ and provided to abutting property owners in advance of the scheduled public hearing;

WHEREAS, in accordance with O.C.G.A. § 32-4-41(4), the County has an affirmative duty to notify the Georgia Department of Transportation within three (3) months that County Line Road East has been abandoned; and


WHEREAS, the notification to the Georgia Department of Transportation shall be accompanied by an appropriate digital file, map or plat depicting the location of the abandoned road.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners, and it is hereby resolved by the authority of the same, as follows:

1. The Board hereby declares County Line Road East and all corresponding County right-of-way lying in Land Lots 104, 105, 127, and 128 of the 1st District of Newton County, Georgia ("County Line Road East"), as shown on the attached plat or sketch (see Exhibit A) to be abandoned.
2. County Line Road East shall no longer be part of the County road system and the rights of the public in and to County Line Road East as a public road shall cease.
3. Within three (3) months of the effective date of this Resolution, timely notification shall be provided to the Georgia Department of Transportation that County Line Road East has been abandoned and such notification shall be accompanied by an appropriate digital file, map or plat depicting the location of the abandoned road.

THIS RESOLUTION is hereby adopted this 2nd day of January, 2018, the public health, safety and general welfare demanding it.

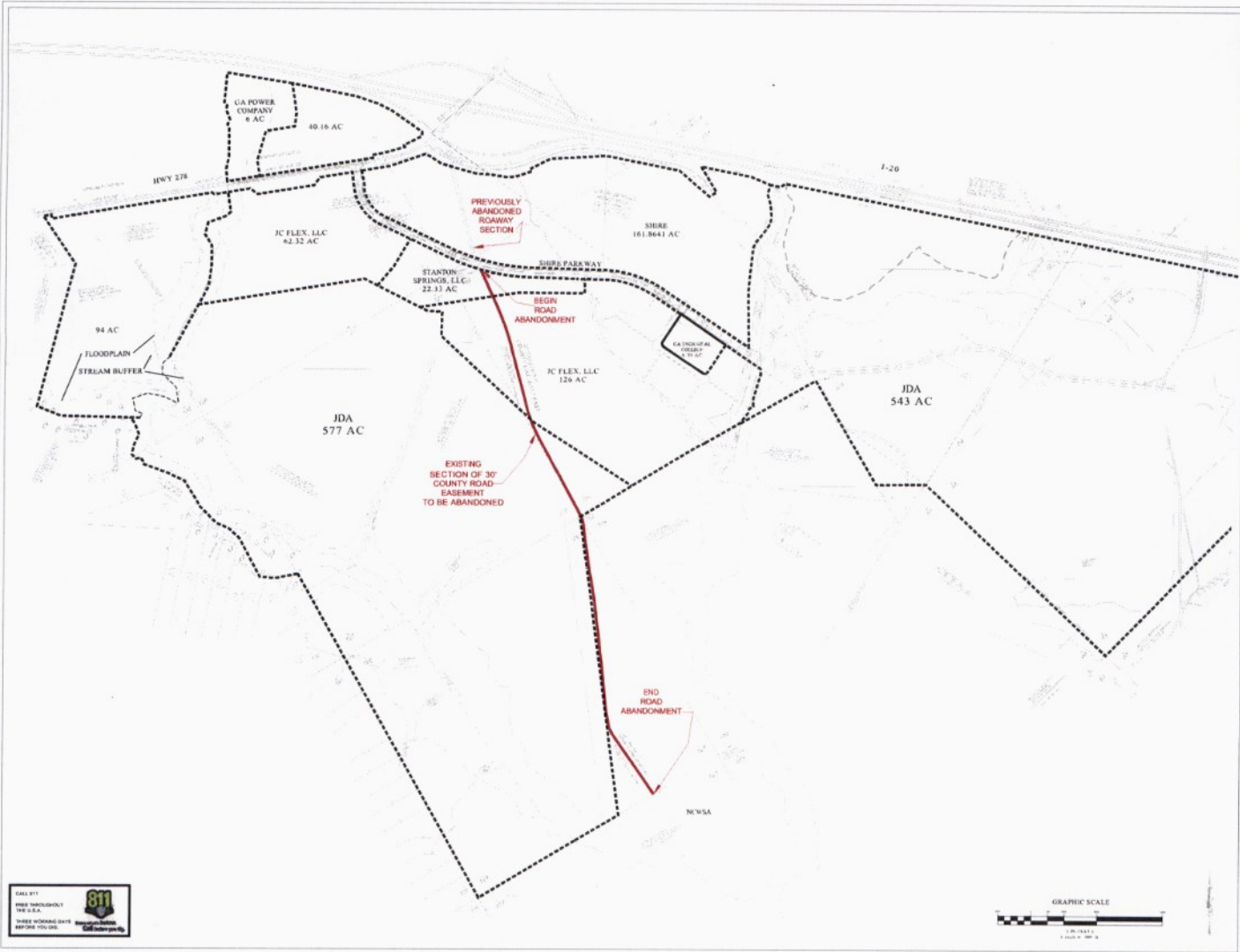
